Civil Service Regulations [Subsidiary] (2)  
In computing length of service for the purposes of subregulation (1), “service” shall include “other public service” and “service in the group” as defined in section 2 of the Pensions Act. \*73.

### **Philadelphia Civil Service Regulations**

Whenever an appointing authority requires the temporary employment of a person who does not have permanent Civil Service status to fill a position for a limited period not to exceed six (6) months, he/she shall so advise the Director, stating the duration of such period, and the duties to be performed.

## **Civil Service Bureau - Home**

Appointments and promotions in the civil service of the State, and of such political subdivisions as may be provided by law, shall be made according to merit and fitness to be ascertained, as far as practicable, by examination, which, as far as practicable, shall be competitive; except that preference in appointments by reason of active service in any branch of the military or naval forces of the United States in time of war may be provided by law.

## **Chapter 10: Performance Evaluation System**

The appointing authority must submit an annual written report to the Human Resources Director listing all appointments made under the provision of this regulation. The Human Resources Director will present an annual report on the regulation to the Civil Service Commission. This regulation shall be retroactive to June 15, 2009. 6.092 - PROMOTIONS.

Each appointing authority shall report or certify performance and interim ratings to civil service staff. 2-3.2 Performance Ratings (a) General. An appointing authority shall evaluate each non-probationary employee's performance and issue a performance rating as the rules and regulations require. (1) Timing.
